This report gives the allocation received per Member State under the Asylum, Migration and Integration Fund (AMIF) and the Internal Security Fund (ISF) border and visa, and police. Long term fund corresponds to the allocation under each national programme as the date of extraction, so includes the basic allocation as defined in the respective legal acts as well as the additional funding received in the annual budgetary procedures since 2015. Emergency assistance corresponds to the allocation awarded to the Member States in the context of an emergency situation as foreseen in the AMIF and ISF legal acts and managed directly or indirectly by the Commission. Committed amounts are net of de-commitments where applicable. In old funds (MFF2014-2020 period) all allocated amounts have been committed.
